2. COMPOSITION/INFORMATION ON INGREDIENTS

Mixture Description : Blend of polyolefins and additives.

3. HAZARDS IDENTIFICATION

pustules and spots on the skin of exposed areas. Ingestion may result in
nausea, vomiting and/or diarrhoea

Environmental Hazards : Not classified as dangerous for the environment.

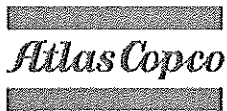
4. FIRST AID MEASURES

General Information : Not expected to be a health hazard when used under normal conditions.

Inhalation : No treatment necessary under normal conditions of use. If symptoms persist,
obtain medical advice

Skin Contact : Remove contaminated clothing. Flush exposed area with water and follow by
washing with soap if available. If persistent irritation occurs, obtain medical
attention

Eye Contact : Flush eye with copious quantities of water. If persistent irritation occurs,
obtain medical attention.

Ingestion : In general no treatment is necessary unless large quantities are swallowed, however, get medical advice.

Advice to Physician : Treat symptomatically.

5. FIRE FIGHTING MEASURES

Clear fire area of all non-emergency personnel.

Flash point : Typical 235 °C / 455 °F (COC)

Upper / lower Flammability or Explosion limits : Typical 1 - 10 %(V).

Auto ignition temperature : > 320 °C / 608 °F

Hazardous Combustion Products and Specific Hazards : Hazardous combustion products may include: A complex mixture of airborne solid and liquid particulates and gases (smoke). Carbon monoxide. Unidentified organic and inorganic compounds.

Suitable Extinguishing Media : Foam, water spray or fog. Dry chemical powder, carbon dioxide, sand or earth may be used for small fires only.

Unsuitable Extinguishing Media : Do not use water in a jet.

Protective Equipment For Firefighters : Proper protective equipment including breathing apparatus must be worn when approaching a fire in a confined space.

6. ACCIDENTAL RELEASE MEASURES

Protective measures : Avoid contact with skin and eyes. Use appropriate containment to avoid environmental contamination. Prevent from spreading or entering drains, ditches or rivers by using sand, earth, or other appropriate barriers.

Clean Up Methods : Slippery when spilt. Avoid accidents, clean up immediately. Prevent from spreading by making a barrier with sand, earth or other containment material. Reclaim liquid directly or in an absorbent. Soak up residue with an absorbent such as clay, sand or other suitable material and dispose of properly.

Additional Advice : Local authorities should be advised if significant spillages cannot be contained.

7. HANDLING AND STORAGE

General Precautions : Use local exhaust ventilation if there is risk of inhalation of vapours, mists or aerosols. Properly dispose of any contaminated rags or cleaning materials in order to prevent fires. Use the information in this data sheet as input to a risk assessment of local circumstances to help determine appropriate controls for safe handling, storage and disposal of.

Handling : Avoid prolonged or repeated contact with skin. Avoid inhaling vapour and/or mists. When handling product in drums, safety footwear should be worn and proper handling equipment should be used.

Storage : Keep container tightly closed and in a cool, well-ventilated place. Use properly labelled and closeable containers. Store at ambient temperature.

Occupational Exposure Limits

- Exposure Controls** : The level of protection and types of controls necessary will vary depending upon potential exposure conditions. Select controls based on a risk assessment of local circumstances. Appropriate measures include: Adequate ventilation to control airborne concentrations. Where material is heated, sprayed or mist formed, there is greater potential for airborne concentrations to be generated.
